

Yearly Perspective -

So far in 2021, Montreal is 38% of the way to match the total deals in 2020 and 87% of the way to match in total investment.




Quarterly Review ——

In Q2, Montreal's tech ecosystem had 26 investments totaling \$756.9M CAD. Montreal saw a 198% increase in total investment and a 37% increase in the number of deals compared to last quarter. If you look back to Q2 2020, this quarter has seen the total investment increase by 46% and the number of deals decrease 33%.

The FinTech vertical led the way this quarter with 20% of the deals followed by Artificial Intelligence at 12% of the deals.


Also of note in Q2 were 3 Private Equity deals in dcbel for \$49M CAD, eStructure for \$600M and Averna for an undisclosed amount.
