



### In Q4, Montreal companies attracted \$198.7M in funding across 20 deals

### Yearly Perspective -


In 2021, Montreal was 73% of the way to match the total deals in 2020 and has surpassed last year in total investment (33% increase). Montreal had a very minor decrease in reported Pre-Seed (17 in 2020 vs 15 in 2021) and Seed (39 in 2020 vs 36 deals in 2021) stage deals this year. With such a small dip in Pre-Seed and Seed deals, this may be due to the classification of company headquarters that companies have used (Montreal or Quebec) or some deals that were not publicly announced. Based on the reported deals, Montreal has a healthy distribution of startups and funding from Pre-Seed through to late stage growth.



## Quarterly Review ——

In Q4, Montreal's tech ecosystem had 20 investments totaling \$198.7M CAD. Montreal saw a 51% decrease in total investment and a 13% decrease in the number of deals compared to last quarter. If you look back to Q4 2020, this quarter has seen the total investment increase by 48% and the number of deals decrease 20%.


In this quarter 15% of the investment deals focused on SaaS based companies and 10% in each BioTech, HealhTech, Markeplace and Platform companies.
